#### Appointments Matters for Discussion and Decision

18/05 <u>Update from the Vice-Chancellor on the Appointment of the Pro-Vice-Chancellor (Research and Innovation)</u> (Item 4)

The Vice-Chancellor reminded the Committee that Professor Mithen's second term of office would end on 31 July 2018. A Selection Panel had been convened including the President of the Council, the Vice-President (Mrs Owen), President of RUSU, the Senate representative on Council, the Vice-Chancellor and external member from the University of Nottingham (Dame Jessica Corner, Pro-Vice-Chancellor Research and Innovation).

The post had been advertised as an internal appointment and four candidates had been shortlisted. Interviews for the post had been held on 26 January 2018.

It was reported that Professor Parveen Yaqoob (Head of School of Chemistry, Food and Pharmacy) and Professor Dominic Zaum (Research Dean for Prosperity and Resilience) had been appointed to the post on a job share arrangement. The Vice-Chancellor informed the Committee that discussions were currently in hand as to how the job share would work in practice.

The Committee noted that the external member was very positive about the quality of the candidates.
