### **Programme information and content**

The programme aims to provide you with a degree-level understanding of the complex global dynamics affecting the planet's resources, climate, food systems, and human population. Through the course of the degree, students are exposed to critical thinking in international development, capturing key ideas in international development policy and practice, illustrated with rich use of case studies from around the world. An interdisciplinary grounding in thinking on international development is combined with opportunities to specialise through learning pathways on society and planning; economics and business; environment and climate change; and food systems and security. The cross-university programme incorporates a wealth of multi-disciplinary expertise, including from geography, economics, international relations, agriculture, and food and nutritional sciences.

Part 1:	Introduces you to themes within international development, including on global-local issues; people, power and policy, food dilemmas, economics, development planning, and sustainability & prosperity. It also provides a basic grounding on studying for a university degree, facilitates the professional development of students through individual and team based learning, and builds communication skills for a range of audiences.
Part 2:	Provides you with the opportunity to apply and expand on knowledge gained in Part 1 through consolidating understanding of core development theories, introducing research methods for international development that can later be applied to a research project, and permitting students to further specialise in subject areas across our four learning pathways.
Part 3:	Gives you the opportunity to undertake an individual research project on a chosen topic, whilst developing deeper knowledge in a range of areas related to global development and socio-economic, environmental and political change around the world.

**Module information**

Each part comprises 120 credits, allocated across a range of compulsory and optional modules as shown below. Compulsory modules are listed.

**Modules during a placement year or study year (if applicable):**

If you are undertaking a year-long placement or a year-long study abroad, students will take one 120 credit module as follows:

As part of the Placement Year, students have the option to take either a full year (minimum of 40 weeks) in full time employment or, with approval from the module convenor and programme director, a shorter work placement (minimum of 20 weeks) combined with a study abroad semester. Students can also select a full year of study abroad. \*Students will

only be eligible for AP2SA3 and AP2SA1 if they meet the criteria and if places are available in overseas institutions – places are not guaranteed.

Students may be permitted to undertake a placement year or a study abroad year between Part 2 and Part 3 of the programme. In such cases students will transfer to a 4-year programme. The placement or study abroad year should not normally be shorter than nine months full-time.

If you take a year-long placement or study abroad, Part 3 as described below may be subject to variation.

Your remaining credits will be made up of optional modules from the School of Agriculture, Policy and Development and Schools across the University, subject to Programme Director approval and timetabling constraints.

### **Additional costs of the programme**

Participation in the optional AP3ID1 Overseas Study Experience in Uganda is subject to fees payable by the student. Estimated cost is £1900.

If you undertake a Placement Year, associated costs will vary according to the nature and location of the placement and/or the study abroad host institution, and individual travel and subsistence arrangements.

Costs are indicative, but will vary according to module choice and are subject to inflation and other price fluctuations. The estimates were calculated in 2017.

### **Optional modules:**

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your Programme is set out in the Further Programme Information. Details of optional modules for each part, including any Additional Costs associated with the optional modules, will be made available to you prior to the beginning of the Part in which they are to be taken and you will be given an opportunity to express interest in the optional modules that you would like to take. Entry to optional modules will be at the discretion of the University and subject to availability and may be subject to pre-requisites, such as completion of another module. Although the University tries to ensure you are able to take the optional modules in which you have expressed interest this cannot be guaranteed.

### **Placement opportunities**

If you take the 4 year degree with a Placement Year, you are required to undertake a compulsory placement as part of your Programme (see section above on Placement). You will be supported in finding this placement.

### **Teaching and learning delivery:**

You will be taught through seminars, lectures, group discussions.

The contact hours for your Programme will be approximately 250-300 hours in Part 1, 250-300 hours in Part 2 and 200 - 250 hours in Part 3 and will depend upon your module combination; however information about module contact hours can be located in the relevant module descriptions.

### **Assessment**

The programme will be assessed through a combination of written examinations and coursework, assessed via a range of methods.

### **Progression**

The University-wide rules relating to 'threshold performance' as follows

#### Part 1

To gain a threshold performance at Part 1 a student shall normally be required to

- (i) obtain an overall average of 40% over 120 credits taken in Part 1; and
- (ii) obtain a mark of at least 30% in individual modules amounting to not less than 100 credits taken in Part 1;

In order to progress from Part 1 to Part 2 of this programme, a student shall normally be required to achieve a threshold performance at Part 1 and;

- (iii) achieve a credit weighted average mark of not less than 40% over the compulsory modules (AP1EE3, AP1ID1, AP1ID3, AP1ID4, FB1FD1, RE1SPGW); and

- (iv) a mark of not less than 30% in each compulsory module.

If you gain a threshold performance at Part 1 and do not proceed to achieve a higher award, you are eligible to receive the award of Certificate of Higher Education. The Part 1 Examination does not contribute to the classification of your degree.

#### Part 2

The Part 2 examination is used to assess a student's suitability to proceed to Part 3 of their programme. It also determines eligibility for the Diploma of Higher Education. In addition, the marks achieved in the Part 2 Examination contribute to the classification of your degree.

To gain a threshold performance at Part 2, a student shall normally be required to achieve:

- (i) a weighted average of 40% over 120 credits taken at Part 2; and
- (ii) marks of at least 40% in individual modules amounting to not less than 80 credits; and
- (iii) marks of at least 30% in individual modules amounting to not less than 120 credits,

except that a mark below 30% may be condoned in no more than 20 credits of modules owned by the Department of Mathematics and Statistics.

In order to progress from Part 2 to Part 3, student must achieve a threshold performance at Part 2. If you gain a threshold performance at Part 2 and do not proceed to achieve a higher award, you are eligible to receive the award of Diploma of Higher Education.

Placement Year/Year Abroad (or combination thereof)

Students are required to pass their year out in order to progress on the programme which incorporates the placement year, study abroad year or combination thereof.

Students who fail the placement year transfer to the non-placement year version of the programme.

### **Classification**

The University's honours classification scheme is based on the following:
