# Programme information and content

The aim of this programme is to equip international pharmacists with the core competencies, knowledge, skills and behaviours that they require to provide pharmaceutical care in the UK practice setting. The modules are focused on patient-centred care, with the learning split between taught and experiential learning. The ethos of the programme is to enhance and develop an independent approach to future learning in support of continuing professional development, utilising the International Pharmaceutical Federation Global Competency Framework to underpin learning and support students to individualise their future learning goals.

The programme has a strong practice focus and will emphasis and develop practitioners' skills in communicating with patients and other healthcare professionals, medicines optimisation and clinical decision making. Students will be supported to undertake a workplace-based project to utilise the wider knowledge and skills they have been learning. In addition, the role of management and leadership in students' future practice will be emphasised to support transition to advanced roles.

#### Part-time or flexible modular arrangements

The programme is delivered as a full-time programme to provide 240 credits. One academic credit represents 10 hours of participant effort spent on learning activities, which

includes all forms of study, taught contact time, preparation of assignments, revision and assessment.

#### Additional costs of the programme

Printing and photocopying facilities are available on campus at a cost of £0.05 per page.

Students may need to complete a pre-sessional English programme to meet the IELTS entry requirements.

As part of ensuring the safety of students, patients and the public, some students will be required to undergo background checks by the UK government Disclosure & Barring Service (DBS). The initial DBS check costs approximately £51.20.

Costs are indicative and are subject to inflation and other price fluctuations.

## **Optional modules**

This programme only contains compulsory modules. Within the experiential learning there may be opportunities to individualise clinical learning, these options will be discussed with students during the programme.

# Placement opportunities

This programme contains a 50% integrated experiential learning experience. There are no other UoR-organised opportunities for study abroad or placements outside of the existing modular arrangements.

## Teaching and learning delivery

The modules may involve a combination of lectures, tutorials, workshops, seminars, practical sessions and simulation. The taught programme content will be delivered as a blended learning approach including face-to-face teaching and directed study where appropriate to learning outcomes. Students will have appropriate support in their experiential learning from workplace-based supervisors.

Total study hours for the taught element of the programme will be 1,200 hours. Total study hours for the experiential learning element of the programme will be 1,200 hours. Students will be expected to undertake guided independent study to develop their skills related to individual patient cases and project work. Information about module contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

#### Assessment

Assessment methods used will be according to those stated in the module descriptions to align to the learning outcomes. These may include a professional portfolio, essays, case studies, pharmaceutical care plans, in-class tests, clinical examination skills (including OSCEs), oral examinations (including presentations), and supervised learning in practice. Some assessments will be formative to support learning during the module, and others are summative to provide the final module mark.

## **Progression**

Where students fail a module their individualised learning plan will be discussed to determine the next steps e.g. exiting with a lesser award.
