Part-time or flexible modular arrangements

Part time participants may either follow all the modules taught in the Autumn term in their first year and all the modules taught in the Spring term in their second year or alternatively may follow half the modules from the Autumn and Spring terms in both their first and

second years. The most appropriate arrangements for individual applications will be discussed with the Course Director. Part time students will be encouraged to consider running a long-term research project over the two years that they are registered on the course but may carry out their research project in either their first or second year, again as is appropriate to their circumstances.

Additional costs of the programme

During your programme of study you will incur some additional costs.

Where applicable, there may be textbooks or other resources which you may find it convenient to purchase, usually at a cost of around £15 to £25 per module. Some books may be available second-hand, which will reduce costs. A wide range of resources to support your curriculum, including textbooks, more specialist studies, and electronic resources, are available through the library.

Printing and photocopying facilities are available on campus at a cost per A4 page of £0.05 (black and white) and £0.30 (colour). Essential costs in this area will be low as most coursework is submitted electronically.

Additional costs amounting to approximately £100 may be incurred to purchase personal clothing and footwear appropriate for fieldwork and site visits in the UK.

Students may bear additional costs associated with their research project (e.g. travel to an external partner or fieldwork travel and accommodation costs) but these will be specific to individual projects and not required for most projects.

Costs are indicative and are subject to inflation and other price fluctuations.

To qualify for a **Postgraduate Certificate**, students must

- i. gain an overall average of 50 or more over 60 credits; and
