Programme information and content

The programme aims to provide students with a deeper knowledge and theoretical understanding of the academic discipline of International Relations than that provided at the undergraduate level. It seeks to acquaint them with the current debates in the field and their relationship to contemporary problems of world politics. It also aims to strengthen their ability for critical analysis of International Relations. It offers the opportunity for specialisation in various aspects of international politics, strategic studies, international political economy, international law, international organisations, and area studies.

The programme comprises of 180 credits, allocated across a range of compulsory and optional modules. Compulsory modules are listed.

The remaining credits will be taken from a list of optional modules from the School of Politics, Economics and International Relations. Up to 20 credits may be replaced with modules from an approved list from across the University.

Part-time or flexible modular arrangements

The programme may be studied part-time over two consecutive years with the dissertation being submitted at the end of the second year of study.

Additional costs of the programme

Students are encouraged to discuss the purchase of textbooks or other resources with the module convenor before purchasing. Some books may be available second-hand, which will reduce costs. A range of resources to support your curriculum, including textbooks, electronic resources and computer facilities are available through the library and through the Department of Politics and International Relations.

Printing and photocopying facilities are available on campus at a cost per A4 page of ± 0.05 (black and white) and ± 0.30 (colour). Essential costs in this area will be low as most coursework is submitted electronically

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your Programme is set out in the Further Programme Information. - ii. the total credit value of all modules marked below 50 must not exceed 55 credits; and

For PG Certificate

To qualify for a **Postgraduate Certificate**, students must

- i. gain an overall average of 50 or more over 60 credits; and
- ii. students must not have any mark below 40.
