### Programme information and content

The aims of this course accord with the Department of Health CYP MH programme, previously known as 'Child and Young person: Improving Access to Psychological Therapies' (CYP IAPT). This course is a taught Diploma programme to train new staff to deliver evidence-based low intensity psychological treatments in the Education setting. On graduation students will be qualified as Education Mental Health Practitioners for Children and Young People (EMHPs). Candidates will hold degrees and will be trained to perform a number of roles under the direct supervision of more senior members of staff including:

- Assessing children and young people's mental health difficulties
- Liaising with referrers
- Planning treatment with children, young people and their families
- Delivering low-intensity evidence-based interventions

Trainees will undertake this programme alongside full-time employment in an NHS commissioned child and adolescent mental health service (CAMHS). They will be trained to work with a diverse range of children young people and families, and in collaboration with different organisations (e.g. schools, local authority, NHS). The programme will develop workers' decision- making abilities and enable them to use supervision and to recognise when and where it is appropriate to seek further advice, a step up or a signposted service. Students are exposed to a variety of teaching methods and practical experience, culminating in the assessment of both the theoretical and skills aspects of the modules.

Candidates for this route will not hold an Honours degree or may hold degree of Third-Class Honours standard or below. Candidates for this route will be able to evidence an ability to study at Level 6 (i.e. previous successful study at level 5; or successful part completion of an Honours degree – level 6).

**Module information**

The programme comprises of 60 credits, allocated across a range of compulsory and optional modules. Compulsory modules are listed.

**Part-time or flexible modular arrangements**

Programme must be undertaken full-time. Students have a maximum of three years in which to complete credits to qualify for the award of Graduate Certificate.

**Teaching and learning delivery**

Teaching will use didactic materials, video and role-play illustrations of key therapeutic techniques and experiential learning.

Total study hours for your programme will be 600 hours. The contact hours for your programme will depend upon your module combination; an average for a typical set of modules on this programme is 60 hours. In addition to your scheduled contact hours, you will be expected to undertake guided independent study and clinical contact hours. Information about module contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

### **Accreditation details**

The programme will be accredited by the British Psychological Society in due course; national programme team (including UoR staff) are working on accreditation committee currently.

Please note: Completion of studies is dependent on employment within an NHS commissioned Child and Adolescent Mental Health Service, access to a clinical caseload and clinical and case management supervision. Students must successfully pass all modules of the training programme. Therefore, a student's studies may be terminated if they are no longer working in an appropriate service and no longer have access to a clinical caseload or access to clinical and case management supervision.

### **Assessment**

Assessment will include recordings of clinical work with children, young people and their families, reflective analysis, in class tests, and practice outcomes portfolio.

On the programme, students have the right to resubmit all coursework on one occasion (with marks capped at the pass mark). However, as this is a clinical programme and assessments involve real patients/clients, there is a programme limit of two pieces of coursework that could be granted 'third attempts' (known as alternative assessments) in exceptional circumstances. As a clinical programme, the University has expectations from students' employing organisations, Health Education England, and professional accrediting bodies to ensure clinical competence standards are met. If there are exceptional circumstances which are likely to affect the student across a number of assessments, they are able to suspend studies, for a maximum of 2 years, in accordance with the University suspension policy.

### **Classification**

To qualify for the award of Graduate Certificate, students must gain an average mark of 40 or more for the programme as a whole, and a mark of at least 40 in every module.

Within each module, every skills-based assessment must be passed with a mark of 50 or more, all portfolio assignments passed (marked as a Pass/Fail) and every written academic assessment must be passed with a mark of 40 or more. Any auto-fails on skills-based assessments will be marked as 0. In addition, in order to pass, students must have attended 100% of the teaching days in each module of the programme.
