### Programme information and content

The programme aims to provide you with a thorough degree level education in economics. It aims to produce economists with a wide knowledge of a range of subject areas, with a particular appreciation of the economic analysis of key societal and policy challenges and the data handling skills to inform and analyse economic policy.

This programme comprises of a foundation year (Part 0) provided through the International Foundation Programme (IFP) which provides access to higher education in Britain to international students who do not possess the normal entry requirements of GCE Advanced level qualifications or the equivalent. Through the part 0 you will be equipped with subject specific and general study skills which will enable you to cope with the demands of undergraduate study. This is achieved through the provision of high quality teaching which is sympathetic to the needs of students from a wide range of educational backgrounds.

Foundation year:	<p>In the Foundation year you will have the opportunity to develop transferable skills through the provision of a compulsory credit-bearing Academic Skills module. The key skills relate to Critical Thinking, Essay Writing, Research, Referencing and avoiding plagiarism, Group Work and Projects, Presentations, and Assessment and Examination techniques. You will also take three 40-credit modules as specified in the module information aligned to the 'A Level' entry requirements for the degree. If your level of English is below the standard specified for undergraduate study, one of these 40 credit modules must be International English.</p> <p>Students starting Part 0 in January will join Part 1 in September of the same year.</p>
Part 1:	<p>Introduces you to the basic underpinnings of modern macroeconomics and microeconomics, and supplements this with an introduction to quantitative techniques and a development of mathematics as used in economics. Students further have a choice of optional modules in economic policy and analysis.</p>
Part 2:	<p>Provides you with the fundamental tools of economic analysis, including software focused empirical methods, and provides the opportunity for students to elect a particular area of economic policy analysis.</p>

Placement/Study abroad year:	A placement year provides the opportunity to obtain practical experience and apply academic knowledge. It also helps provide focus in the final year of academic study. Students gain transferable skills demanded by graduate employers and on return to university are better informed about future career paths. A year abroad provides the opportunity for students to broaden both their academic and cultural awareness. As a year abroad does not contribute to the final degree classification, although students are required to take some economics modules, the opportunity exists to study a wider range of topics.
Part 3:	Gives you the opportunity to deepen the theoretical treatment of economics with options providing the opportunity to diversify into specific applications, often with a view to policy analysis, while retaining a spread across both microeconomic and macroeconomic topics. In addition, students will be given the option to research an independently chosen topic through a dissertation supervised by one of the staff members enhancing independent learning, research, writing and analytical skills.

### Module information

Part 0 comprises 140 credits and Parts 1, 2 and 3 each comprise 120 credits, allocated across a range of compulsory and optional modules as shown below. Compulsory modules are listed.

### Foundation modules:

Students entering in the January cohort will take the compulsory module IF0ACJ Academic Skills instead of IF0ACA Academic Skills.

The remaining credits will be made up of optional modules available from a list provided by the International Foundation Programme.

If your level of English is below the standard specified for undergraduate study, one of these 40 credit modules must be IF0IE1 (or IF0IEJ) International English.

Students must select one 20 credit optional module in Economics.

Students on the 4 year with placement year programme will take a zero credit module in placement training.

Remaining credits will be made up of optional modules available in the Department of Economics and modules from elsewhere in the University.

Students must select one 20 credit optional module in Economics.

Students on the 4 year with placement year programme will take a zero credit module in placement training.

Remaining credits will be made up of optional modules available in the Department of Economics and modules from elsewhere in the University.

**Modules during a placement year or study year (if applicable):**

Students on one of the 4 year programmes will take one 120 credit module in either Work Experience or Study Abroad.

Students may be permitted to undertake a placement year or a study abroad year between Part 2 and Part 3 of the programme. In such cases students will transfer to a 4-year programme. The placement or study abroad year should not normally be shorter than nine months full-time.

If you take a year-long placement or study abroad, Part 3 as described below may be subject to variation.

**Part 3 Modules:**

Students must select at least 20 credits from a list of microeconomics based modules and at least 20 credits from a list of macroeconomics based modules.

Remaining credits will be made up of optional modules available in the Department of Economics. Up to 20 credits may be selected from modules available elsewhere in the University.

**Optional modules:**

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your Programme is set out in the Further Programme Information. Details of optional modules for each part, including any Additional Costs associated with the optional modules, will be made available to you prior to the beginning of the Part in

which they are to be taken and you will be given an opportunity to express interest in the optional modules that you would like to take. Entry to optional modules will be at the discretion of the University and subject to availability and may be subject to pre-requisites, such as completion of another module. Although the University tries to ensure you are able to take the optional modules in which you have expressed interest this cannot be guaranteed.

### **Additional costs of the programme**

During your programme of study you will incur some additional costs.

For textbooks and similar learning resources, we recommend that you budget up to £400 per year. This figure is approximate. Actual costs will vary depending on individual study technique, preferences, and requirements. Some books may be available second-hand, which will reduce costs. A range of resources to support your curriculum, including textbooks and electronic resources, are available through the library. Reading lists and module specific costs are listed on the individual module descriptions.

Printing and photocopying facilities are available on campus at a cost of £0.05 per page.

Costs are indicative and may vary according to optional modules chosen and are subject to inflation and other price fluctuations.

The estimates were calculated in 2020.

### **Placement opportunities**

#### **Placements:**

You may be provided with the opportunity to undertake a credit-bearing placement as part of your Programme. This will form all or part of an optional module. You will be required to find and secure a placement opportunity, with the support of the University.

#### **Study Abroad:**

You may be provided with the opportunity to undertake a Study Abroad placement during your Programme. This is subject to you meeting academic conditions detailed in the Programme Handbook, including obtaining the relevant permissions from your School, and the availability of a suitable Study Abroad placement. If you undertake a Study Abroad placement, further arrangements will be discussed and agreed with you.

### **Teaching and learning delivery:**

You will be taught through lectures, tutorials and computer classes.

Total study hours for each Part of your programme will be 1200 hours. The contact hours for your programme will depend upon your module combination; an average for a typical set of modules on this programme is Part 1 - 240 hours, Part 2 - 192 hours, Part 3 - 132 hours. In addition to your scheduled contact hours, you will be expected to undertake guided independent study. Information about module contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

## Assessment

The programme will be assessed through a combination of written examinations, coursework (including class tests) and oral examinations.

## Progression Requirements

Progression Part 0 Foundation Year

The University-wide rules relating to 'threshold performance' as follows

- i. an overall average of at least 40% over all modules taken in Part 0;
- ii. no more than 40 credits of these modules with a mark below 35%
- iii. at least 40% in the Academic Skills module

To progress to Part 1, students must satisfy the following progression and English language requirements:

- i. at least 55% in each of two 40 credit modules, including any specified modules.
- ii. an average of at least 40% in the remaining two modules
- iii. at least 40% in the Academic Skills module 4.
- iv. no module mark below 35%

In addition, students taking module International English (IF0IE1 or IF0IEJ) must obtain 55% in that module.

The achievement of a threshold performance at Part 0 qualifies a student for a Certificate of Completion if he or she leaves the University before completing the subsequent Part.

The University-wide rules relating to 'threshold performance' as follows

### *Part 1*

- (i) obtain an overall average of 40% over 120 credits taken in Part 1; and
- (ii) obtain a mark of at least 30% in individual modules amounting to at least 100 credits taken in Part 1.

In order to progress from Part 1 to Part 2, a student must achieve a threshold performance; and

- (iii) obtain a weighted average of 40% across all compulsory modules in Economics at Part 1 (EC107, EC113, EC114, EC115, EC116, EC123); and
- (iv) obtain marks below 40%, but at least 30%, in compulsory modules in Economics amounting to not more than 20 credits.

***For students transferring from BSc Economics or BSc Business Economics or BSc Economics and Econometrics into Part 2 of BA Economics, alternative level 4 modules in Economics, up to 20 credits, may be substituted in the list of compulsory modules in place of EC107 and/or EC123. Students would then be subject to the progression rules applicable to students on BA Economics.***

The achievement of a threshold performance at Part 1 qualifies a student for a Certificate of Higher Education if they leave the University before completing the subsequent Part.

#### ***Part 2***

To gain a threshold performance at Part 2, a student shall normally be required to:

- (i) obtain a weighted average of 40% over 120 credits taken at Part 2; and
- (ii) obtain marks of at least 40% in individual modules amounting to at least 80 credits; and
- (iii) obtain marks of at least 30% in individual modules amounting to at least 120 credits, except that a mark below 30% may be condoned in no more than 20 credits of modules owned by the Department of Mathematics and Statistics.

In order to progress from Part 2 to Part 3 in the **3 year programme**, a student must achieve a threshold performance

In order to progress from Part 2 to Part 3 in the **4 year programme**, a student must achieve a threshold performance and obtain a pass in the professional/workplacement or study abroad year. Students who fail the professional/placement year transfer to the non-placement year version of the programme.

The achievement of a threshold performance at Part 2 qualifies a student for a Diploma of Higher Education if they leave the University before completing the subsequent Part.
