### **Programme information and content**

The programme aims to provide you with both subject-specific knowledge in human geography and economics and more general skills.

It aims:

To give you a thorough insight into the importance of a geographic perspective on human processes, including the manner in which these processes operate at global, regional and local scales.

To develop your understanding of the working of economic processes of production and exchange and their applicability to a wide range of different situations.

To develop your understanding of the theory and practice of human geography and economics, together with the ability to integrate these perspectives.

To encourage you to discover and make good use of theories and research findings from human geography, economics and related disciplines.

To develop your skills in applying theoretical concepts, knowledge and philosophies to the understanding of particular environments, spatial differences and to decision-making.

To develop your knowledge through fieldwork and other forms of experiential learning.

To develop your appreciation of the interdisciplinary nature of knowledge to promote your ability to engage in lifelong learning.

The programme aims to produce graduates with subject-specific skills and knowledge in both Economics and Geography with a particular emphasis on understanding issues of urban and regional development. An important feature of the degree is its emphasis on the critical comparison and integration of material and perspectives from the two disciplines.

Part 1:	Introduces you to the disciplines of geography and economics, including current scholarly debates and theories in research, the history and intellectual traditions of the disciplines and their application to understanding contemporary issues. You will also be introduced to research and study skills that will develop your capabilities as an independent learner.
Part 2:	Provides you with opportunities to engage with more specialist areas of research, relevant to the interests of academic staff in the departments, and to develop your independent research skills through a range of field-based and practical training.
Placement/Study abroad year:	You may be permitted to undertake a placement year or a study abroad year between Part 2 and Part 3 of the programme. In such cases you will transfer to a 4-year programme. The placement or study abroad year should not normally be shorter than nine months full-time.
Part 3:	Gives you the opportunity to increase your specialisation through a range of specialist subject modules from which a choice is made, and conduct an original, independent research project.

### Module information

Each part comprises 120 credits, allocated across a range of compulsory and optional modules as shown below. Compulsory modules are listed.

Students will be required to select a further 20 credits from a list of Geography and Environmental Science optional modules. A further 20 credits must be selected from a list of Economics modules.

**Modules during a placement year or study year (if applicable):**

Students on the 4 year version of the programme will take one 120 credit module during their placement/study abroad year.

Students may be permitted to undertake a placement year or a study abroad year between Part 2 and Part 3 of the programme. In such cases students will transfer to a 4-year programme. The placement or study abroad year should not normally be shorter than nine months full-time.

If you take a year-long placement or study abroad, Part 3 as described below may be subject to variation.

Students will be required to select further credits to total 120 credits for the academic year from subject specific lists provided by the School of Archaeology, Geography and Environmental Sciences.

**Optional modules:**

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your Programme is set out in the Further Programme Information. Details of optional modules for each part, including any Additional Costs associated with the optional modules, will be made available to you prior to the beginning of the Part in which they are to be taken and you will be given an opportunity to express interest in the optional modules that you would like to take. Entry to optional modules will be at the discretion of the University and subject to availability and may be subject to pre-requisites, such as completion of another module. Although the University tries to ensure you are able to take the optional modules in which you have expressed interest this cannot be guaranteed.

**Additional costs of the programme**

You will have the option of attending a Part 1 field class, which will require a contribution to costs for your food and board of approximately £75. You will be required to make a contribution to a compulsory Part 2 field class of approximately £300. Bursaries and other

forms of financial support are available for students in financial difficulty. You will be expected to be equipped with suitable outdoor clothing and footwear for field classes. There are no compulsory textbooks and the library has an extensive collection to support your curriculum, including textbooks and electronic resources, are available through the library. Reading lists and module specific costs are listed on the individual module descriptions. You may want to budget around £75/year to purchase your own copy of core course books. Discounted second hand copies may be available. Depending on your module choices, you may choose a non-compulsory Part 3 field class, which will require a financial contribution of approximately £750. Bursaries and other financial support for students in financial difficulty are also available for non-compulsory field classes.

Costs are indicative, but will vary according to module choice and are subject to inflation and other price fluctuations. The estimates were calculated in 2021.

### **Placement opportunities**

You may be provided with the opportunity to undertake a credit-bearing placement as part of your Programme. This will form all or part of an optional module. You will be required to find and secure a placement opportunity, with the support of the University.

### **Teaching and learning delivery:**

You will be taught through a combination of lectures, seminars, practicals, fieldtrips and laboratory based sessions.

The contact hours for your Programme will be approximately 720 hours and will depend upon your module combination; however information about module contact hours can be located in the relevant module description.

### **Assessment**

The programme will be assessed through a combination of written examinations, coursework, presentations and practical exercises.

### **Progression**

The University-wide rules relating to 'threshold performance' as follows

Part 1

- (i) obtain an overall weighted average of 40% in 120 credits
- (ii) obtain a mark of at least 30% in individual modules amounting to at least 100 credits taken in Part 1.

In order to progress from Part 1 to Part 2, a student must achieve a threshold performance.

The achievement of a threshold performance at Part 1 qualifies a student for a Certificate of Higher Education if they leave the University before completing the subsequent Part.

## Part 2

To gain a threshold performance at Part 2, a student shall normally be required to:

- (i) obtain a weighted average of 40% over 120 credits taken at Part 2; and
- (ii) obtain marks of at least 40% in individual modules amounting to at least 80 credits; and
- (iii) obtain marks of at least 30% in individual modules amounting to at least 120 credits, except that a mark below 30% may be condoned in no more than 20 credits of modules owned by the Department of Mathematics and Statistics.

In order to progress from Part 2 to Part 3 in the 3 year programme, a student must achieve a threshold performance

In order to progress from Part 2 to Part 3 in the 4 year programme, a student must achieve a threshold performance and obtain a pass in the professional/work placement or study abroad year. Students who fail the professional/placement year transfer to the non-placement year version of the programme.

The achievement of a threshold performance at Part 2 qualifies a student for a Diploma of Higher Education if they leave the University before completing the subsequent Part.
