- to develop their research skills and prepare them, where appropriate, for a PhD.

Learn through a combination of classes, seminars, reading groups, lectures and guest speaker events; and focus your research into your chosen area of study. Our MA by Research programme is ideal preparation if you are considering undertaking future doctoral research.

The flexibility of our MA by Research programme enables you to pursue your interests. Structured into weekly seminars where all students present their ongoing work to peers and academics, the course offers regular, individual supervision with expert members of staff in your chosen field. This course will provide you with valuable skills and the knowledge to succeed, whether you're looking to further your studies or pave the way for a change of career. We run a number of events throughout the year dedicated to stimulating and fostering research. These include a full visiting speaker programme, a work-in-progress programme, a graduate seminar, a regular staff-student reading group, and the highly regarded annual Ratio Conference. Module information

The MA by Research involves three essay modules (obligatory, but all contents chosen by students individually):

(a) **Three** individually supervised essays:

Module 1: Essay 1: 5-6,000 words (20 credits),

Module 2: Essay 2: 5-6,000 words (20 credits),

Module 3: Essay 3: 7-8,000 words (30 credits),

Module 4: (b) A formal oral presentation of your work (10 credits) in

Module 5: (c) A dissertation of **not more than 20,000 words** (100 credits)

It is completed in 1 year full time or 2 years part time.

The Department encourages students to spread their interests over different areas, for their own benefit. So while students are allowed to do all their essays from only one of these areas, the Department strongly encourages wider coverage. If essays are done from only one area, coverage of disparate topics within those areas is of course required.

In addition you **must** attend classes in Research Methods held at the beginning of the year.

The MA by Research can be studied on a **part time** basis over 2 years. Part-time students are expected to be in the Department once a week (with rare exceptions), to attend the MA by Research seminar. Other events that take place on Tuesdays and Thursdays may be attended at the student's discretion.

The programme comprises 180 credits, allocated across a range of compulsory and optional modules as shown below. Compulsory modules are listed.

Teaching and learning delivery

Teaching is primarily by means of individually supervised research essays and supervised dissertation, supplemented by classes according to student interest and staff research activity. Total study hours for your programme will be 1800 hours. The contact hours for your programme will depend upon your voluntary attendance of additional classes, seminars, and talks. They would be likely to amount to 6-10 hrs/week. In addition to your scheduled contact hours, you will be expected to undertake guided independent study and research.

Elements of your programme will be delivered via digital technology.

The scheduled teaching and learning activity hours and amount of technology enhanced learning activity for your programme will depend upon your module combination. In addition, you will undertake some self-scheduled teaching and learning activities, designed by and/or involving staff, which give some flexibility for you to choose when to complete them. You will also be expected to undertake guided independent study. - (iii) not more than 20 credits with a mark below 40%
- (iv) a mark of 50% or more for the Dissertation

In addition to the threshold conditions for the award of a Master's degree, the following **further** conditions must be satisfied for a classification of Distinction or Merit:

Distinction

An overall weighted average of 70% or more over 180 credits

an overall weighted average of 68% or more over 180 credits and marks of 70% in at least 90 credits

AND

A mark of at least 60% in the dissertation

AND

No marks below 40%.

Merit

An overall weighted average of 60% or more over 180 credits

OR

an overall average of 58% or more over 180 credits and marks of 60% in at least 90 credits AND

No marks below 40.

For Postgraduate Diploma

The following conditions must be satisfied for the award of a Postgraduate Diploma:

Award of a Postgraduate Diploma

- (i) an overall weighted average of 50% or more over 120 credits
- (ii) a mark of 50% or more in at least 80 credits
- (iii) not more than 20 credits with a mark below 40%

In addition to the threshold conditions for the award of a Postgraduate Diploma, the following further conditions must be satisfied for a classification of Distinction or Merit:

Distinction

An overall weighted average of 70% or more over 120 credits

OR

an overall weighted average of 68% or more over 120 credits and marks of 70% in at least 60 credits

AND

No marks below 40.

Merit

An overall weighted average of 60% or more over 120 credits

OR

an overall average of 58% or more over 120 credits and marks of 60% in at least 60 credits AND

No marks below 40.

For Postgraduate Certificate

The following conditions must be satisfied for the award of a Postgraduate Certificate:

Award of a Postgraduate Certificate

(i) an overall weighted average of 50% or more over 60 credits

Additional costs of the programme

There are no textbooks which you must buy and students are encouraged to discuss the purchase of textbooks or other resources with the module convenor before purchasing. Some books may be available second-hand, which will reduce costs. A range of resources to

support your curriculum, including textbooks, electronic resources and computer facilities, are available through the library and through the Department of Philosophy. Printing and photocopying facilities are available on campus at a cost per A4 page of £0.05 (black and white) and £0.30 (colour). Essential costs in this area will be low as most coursework is submitted electronically.
