## **Programme information and content**

The aim of the programme is to provide a coherent framework for the discipline and practice of project management. The distinctive focus of the programme is on the strategic management of construction projects, programmes and portfolios. A particular emphasis is given to the early stages of construction projects and the interface with complex client systems.

Each module includes sessions delivered by leading practitioners. The programme is continually informed not only by the latest developments in industry, but also by on-going international research. A recurring theme throughout the programme concerns the dynamic nature of construction projects. Not only is it necessary to set clear objectives at the beginning of a project, it is also important for the objectives to appropriately evolve to accommodate fluid project constraints and requirements. A further theme is the need for

project managers to provide leadership. This requires a high level of interpersonal skill to motivate diverse team members towards the realisation of project success. Effective project management requires a sound knowledge of technical and process tools and techniques. It also requires an ability to think strategically. Traditional notions of 'command and control' must be matched with an ability to manage 'soft' issues. People management is central to the art of project management.

For the MSc Project Management with Industry placement, the first year of the MSc is the taught modules, which are the same as the standard MSc Project Management. After the first year, once the students met the minimum requirements for pass in the standard MSc (Please see the Classifications in this document for the requirements of Pass (or above)), they will start the placement in November of the second year. Please note that the onus to secure a placement is upon the student but support will be provided by the School, primarily through the Placement module. The students will need to inform the module convenor of the Placement module by the end of September, in writing, of securing the placement. Should the student fail to secure the placement by this date, they will be reverted to the standard programme and will be graduated with the relevant classifications in the standard programme.

The aim of the placement year is to apply the knowledge that the students gain in their first year of MSc in a relevant industry role. Students graduating from this programme will have the opportunity to showcase their capabilities and knowledge to the employers for an enhanced chance of securing a permanent position in the industry either within the UK or anywhere else in the world.

You will be expected to engage in learning activities to achieve these Programme learning outcomes. Assessment of your modules will reflect these learning outcomes and test how far you have met the requirements for your degree.

Part-time students will take the compulsory modules Principles and Practice of Project Management A (CEM13A) and Principles and Practice of Project Management B (CEM13B) in place of Principles and Practice of Project Management (CEM103).

The Year 2 compulsory module CEM500 is only for students who are on the placement version of the programme.

The optional modules for the programme with placement is exactly the same as the standard programme.

#### Part-time or flexible modular arrangements

This programme may be taken on a flexible-modular basis, normally over 24 months for September starts or 33 months for February starts, up to a maximum of 63 months. February starts involve spreading the period of study over three academic years, with a view to graduating in December of the third year.

The MSc Programme with placement is offered only on a full-time basis.

#### **Placement opportunities**

The standard MSc Programme does not have any formal arrangements for study abroad or placement.

The MSc with Industry Placement has one year of placement in the construction industry within UK.

#### Study abroad opportunities

There are no formal arrangements for study abroad.

#### **Optional modules**

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your programme can be found online in the Course Catalogue. Details of optional modules for each part, including any additional costs associated with the optional modules, will be made available to you prior to the beginning of the Part in which they are to be taken and you will be given an opportunity to express interest in the optional modules that you would like to take. Entry to optional modules will be at the discretion of the University and subject to availability and may be subject to pre-requisites, such as completion of another module. Although the University tries to ensure you are able to take the optional modules in which you have expressed interest this cannot be guaranteed.

The optional modules for the programme with placement is exactly the same as the standard programme.

#### **Teaching and learning delivery**

The programme is delivered face-to-face on campus through a combination of instructor-led and student-led learning and teaching approaches including lectures (by both University staff and guest speakers from industry), site visits, seminars, tutorials, group work and interactive sessions depending on the modules chosen.

In the MSc with industry placement, the students will be visited in their place of work during their placement by the Placement module convenor once per semester to ensure the processes are meeting the quality standards and they students are given the opportunity to make the most of their placement.

Elements of your programme will be delivered in conjunction with the use of University's online learning and teaching platforms (i.e. Blackboard).

Elements of your programme will be delivered via digital technology.

The scheduled teaching and learning activity hours and amount of technology enhanced learning activity for your programme will depend upon your module combination. In addition, you will undertake some self-scheduled teaching and learning activities, designed by and/or involving staff, which give some flexibility for you to choose when to complete them. You will also be expected to undertake guided independent study. Information about module study hours including contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

#### Accreditation details

The MSc Project Management programme is accredited by the Chartered Institute of Building, the Royal Institution of Chartered Surveyors and the APM's Chartered Project Professional (ChPP) Recognised Assessment via route 1 (for assessments meeting the requirements for technical knowledge).

For the MSc with Placement, accreditation is to be sought from the Chartered Institute of Building (CIOB), Royal Institution of Chartered Surveyors (RICS) and Association for Project Management (APM)

## Assessment

The general assessment pattern for the programme is by coursework. There are no written examinations in this programme. Each 20-credit module will typically have two major assignments. Assessment is through a combination of written reports, essays, class tests, group projects, oral examinations, digital deliverables, and the research dissertation. Further information is contained in the individual module descriptions.

The assessment of the MSc with Industry placement during the first year is exactly the same as the standard MSc. The assessment of the placement year is based on a report that is graded as fail or pass.

## Progression

N/A

The students on the MSc with Industry placement need to meet the minimum requirements of the pass in their first year (from taught modules and the dissertation) to be eligible to start the placement. Should the students fail to meet the minimum requirements of Pass, they will be reverted to the standard programme to have the opportunity to graduate with either a Postgraduate Diploma or a Postgraduate Certificate. If the student meets the minimum requirements and proceed with the placement year but fail the Industry Placement module, they will fail the Programme.

## Classification

The University's taught postgraduate marks classification is as follows:

## For Masters Degree

The following conditions must be satisfied for the award of a Master's degree:

# Award of a Master's degree

(i) an overall weighted average of 50% or more over 180 credits

(ii) a mark of 50% or more in at least 120 credits

(iii) not more than 20 credits with a mark below 40%

(iv) a mark of 50% or more for the Dissertation

Students on the placement version of the programme: (v) must achieve a pass in the Industry Placement module (CEM500).

In addition to the threshold conditions for the award of a Master's degree, the following **further** conditions must be satisfied for a classification of Distinction or Merit:

## Distinction

An overall weighted average of 70% or more over 180 credits OR an overall weighted average of 68% or more over 180 credits and marks of 70% in at least 90 credits AND A mark of at least 60% in the dissertation AND No marks below 40%.

An overall weighted average of 60% or more over 180 credits OR an overall average of 58% or more over 180 credits and marks of 60% in at least 90 credits AND No marks below 40.

# For Postgraduate Diploma

The following conditions must be satisfied for the award of a Postgraduate Diploma:

# Award of a Postgraduate Diploma

(i) an overall weighted average of 50% or more over 120 credits

(ii) a mark of 50% or more in at least 80 credits

(iii) not more than 20 credits with a mark below 40%

The qualification of PG Diploma excludes CEM10A and CEM10B. Where the conditions for a higher class have been met, the higher class should be awarded.

In addition to the threshold conditions for the award of a Postgraduate Diploma, the following further conditions must be satisfied for a classification of Distinction or Merit:

# Distinction

An overall weighted average of 70% or more over 120 credits OR an overall weighted average of 68% or more over 120 credits and marks of 70% in at least 60 credits AND No marks below 40.

# Merit

An overall weighted average of 60% or more over 120 credits OR an overall average of 58% or more over 120 credits and marks of 60% in at least 60 credits AND No marks below 40.

# For Postgraduate Certificate

The following conditions must be satisfied for the award of a Postgraduate Certificate:

## Award of a Postgraduate Certificate

(i) an overall weighted average of 50% or more over 60 credits

The qualification of PG Certificate excludes CEM10A, CEM10B and CEM103 and CEM13A and CEM13B.

## Additional costs of the programme

Students need to purchase a pair of safety boots with steel toe caps for construction site visits which cost around £50.

Where applicable, core textbooks recommended for student purchase may cost around £15 to £25 per module; there may be other books/resources which you would find it convenient to buy. Some books may be available second-hand, which will reduce costs. A wide range of resources to support your curriculum, including textbooks, more specialist studies, and electronic resources, are available through the library.

For the MSc with Industry placemen, the costs of commute to the placement are not included in here. This may vary depending on its location. Some firms might reimburse the travel expenses but that is not guaranteed.

Costs are indicative and may vary according to optional modules chosen and are subject to inflation and other price fluctuations. The estimates were calculated in 2023.
