Programme information and content

The aim of the LLB is to provide legal education not only in the core areas of English law required to be awarded a qualifying law degree (QLD) but also in a variety of specialisms that enrich the student's experience and understanding of how law is used to solve disputes or achieve change. The overarching educational aim of this course is to not only impart legal knowledge but: to situate the law within wider global, national policy and practice contexts; to equip students with skills necessary for research, critical analysis, and application of law in a range of issues; and to provide opportunities for students to start developing the skills crucial to legal practice.

Part 1:	You will study for Part 1 at Brickfields College Asia.
Part 2:	Part 2 may be taken either at Brickfields Asia College or in Reading. If you take Part 2 in Reading, you will study the remaining compulsory subjects of the qualifying law degree and continue to develop your ability to work with primary legal resources, research the law and set out your conclusions.

	If you studied Part 2 in Reading, you will already have completed the necessary subjects for the qualifying law degree. You must still choose one from a range of independent research-based modules to demonstrate mastery of legal writing, legal research and the construction of a legal argument. In addition, the School offers a range of modules from which you can choose your remaining credits at Part 3. This choice affords you a greater opportunity to focus your study on the areas of the law that interest you most.

Optional modules:

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your programme can be found online in the Course Catalogue. Details of optional modules for each part, including any additional costs associated with the optional modules, will be made available to you prior to the beginning of the Part in which they are to be taken and you will be given an opportunity to express interest in the optional modules that you would like to take. Entry to optional modules will be at the discretion of the University and subject to availability and may be subject to pre-requisites, such as completion of another module. Although the University tries to ensure you are able to take the optional modules in which you have expressed interest this cannot be guaranteed.

Teaching and learning delivery:

You will be taught primarily through a mixture of lectures, workshops, seminars and tutorials, depending on the modules you choose. Elements of your programme will be delivered via digital technology. The contact hours for your programme will depend upon your module combination; an average for a typical set of modules on this programme is around 220 hours. Some modules may include group work. In addition, you will undertake some self-scheduled teaching and learning activities, designed by and/or involving staff, which give some flexibility for you to choose when to complete them. You will also be expected to undertake guided independent study. Information about module study hours including contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

Accreditation details

Please note that the School of Law intends that the LLB will be a UK qualifying law degree (QLD), where still relevant, for all students and will make any necessary changes to the degree programme to ensure it stays a QLD or continues to satisfy any modified professional requirements for the academic stage of training stipulated by the professional

bodies. All other aspects of the degree programme may be subject to change where such change is educationally desirable or practically necessary.

Assessment

The programme will be assessed through a combination of different types of assessments including more traditional methods such as written examinations and coursework (including through presentations and podcasts) as well as, for example, participation in advocacy or negotiation, writing client letters and writing reflectively about learning experiences. Further information is contained in the individual module descriptions.

Progression

Part 1

In order to proceed from Part 1 at Brickfields Asia College to Part 2 of the degree, at Reading, a student must:

- i. Obtain an overall average of 50% across all credits for which a numerical mark is awarded; and
- ii. Obtain a pass in those subjects for which a numerical mark is not awarded; and
- iii. Obtain a pass of at least 40% in all compulsory modules listed at Part 1.

Part 2

At the University of Reading

To achieve a threshold performance at Part 2, a student shall normally be required to:

- i. Obtain a weighted average of 40% over 120 credits taken in Part 2; and
- ii. Obtain marks of at least 40% in individual modules amounting to at least 80 credits taken in Part 2; and
- iii. Obtain marks of at least 30% in individual modules amounting to at least 120 credits, except that a mark below 30% may be condoned in no more than 20 credits of modules owned by the Department of Mathematics and Statistics.

In order to progress from Part 2 to Part 3, a student must achieve a threshold performance; and

i. obtain marks of at least 40% in LW1TOR, LW2ETR, LW2EUL, LW2LND, and LW2PL2.

The achievement of a threshold performance at Part 2 qualifies a student for a Diploma of Higher Education if they leave the University before completing the subsequent Part.

At Brickfields College Asia

In order to proceed from Part 2 at Brickfields Asia College to Part 3 of the degree, at Reading, a student must:

- i. obtain an overall average of 60% across all credits for which a numerical mark is awarded; and
- ii. obtain a pass in those subjects for which a numerical mark is not awarded; and
- iii. obtain at least 40% in Land Law and the Law of Tort; and
- iv. obtain an overall average of 50% in their Part 1 examinations.

Classification
