Programme information and content

The Primary Professional Graduate Primary ITE programme is designed to equip well-qualified graduates with the professional skills necessary to become committed, effective, reflective, early career teachers who can respond flexibly to changing circumstances, maintain and enhance educational standards in primary schools and continue to develop their knowledge, skills and understanding throughout their professional lives.

The programme will furnish candidates with the knowledge, skills and understanding to plan, deliver and evaluate lessons that meet Early Years Foundation Stage guidance (if on 3-7 pathway), the National Curriculum and assessment requirements, monitor pupils' achievements and understand how to help each individual child reach their potential.

The programme is a one-year, postgraduate programme leading to a recommendation for Qualified Teacher Status (QTS) at the end of the programme upon successful completion. This programme leads to the:

Professional Graduate Certificate in Education with QTS (PgCE):

Students will complete 120 level 6 credits (placements) and achieve QTS

There will be an option of three different pathways. They will be:

- General Pathway
- 3-7 Pathway
- SEND Pathway

Each pathway gives the same exit award and develops the same skills and attributes from the core sessions. However, the placements that the students complete along with **additional** taught sessions, will give the students the subject knowledge and additional skills to work in a special setting or early years setting. The General pathway students will receive content based around leading different areas of the curriculum during this time,

including Climate Change and Sustainability education, leading a STEM subject and Humanities.

Programme Learning Outcomes

During the course of the Programme, you will have the opportunity to develop a range of skills, knowledge and attributes (known as learning outcomes) For this programme, these are:

	Learning outcomes
1	Evidence-informed teachers, with the knowledge and understanding of teaching as a professional and research-based activity, showing awareness of key issues in education and how they impact school settings
2	Compassionate professionals, who are able to be empathetic and inclusive, showing pastoral understanding of children's needs
3	Responsive and reflective practitioners who are pedagogically skilled in order to meet the diverse needs of all learners
4	Creative critical curriculum thinkers, who develop rich subject knowledge and informed teacher autonomy in order to manage the challenges of the 21st century curriculum
5	Ethical community participants who understand social justice and how this intersects with being a responsible local and global citizen
6	Knowledgeable about all aspects of the ITT Core Content Framework and able to demonstrate that they meet the Teachers' Standards at the end of the programme.

You will be expected to engage in learning activities to achieve these Programme learning outcomes. Assessment of your modules will reflect these learning outcomes and test how far you have met the requirements for your degree.

To pass the Programme, you will be required to meet the progression or accreditation and award criteria set out below.

The programme comprises 120 level 6 credits as shown below.

PATHWAYS

There will be three pathways available:

- a. General Primary

- b. 3-7 Pathway
- c. Special Educational Needs and Disabilities (SEND)

Part-time or flexible modular arrangements

The 120-credit PgCE is not available as a part-time option.

Placement opportunities

The three level 6 modules are placement modules. This programme offers substantial experience in at least two schools, spanning a minimum of four school year groups.

Study abroad opportunities

There are no study abroad options.

Optional modules

There are no optional modules.

Teaching and learning delivery

University based teaching includes lectures, tutor and student led seminars and workshops and feedback on individual and group research and presentation. Teaching in Partnership schools includes observations and feedback, in-service sessions and working collaboratively.

Elements of your programme will be delivered via digital technology.

The scheduled teaching and learning activity hours and amount of technology enhanced learning activity for your programme will depend upon your module combination. In addition, you will undertake some self-scheduled teaching and learning activities, designed by and/or involving staff, which give some flexibility for you to choose when to complete them. You will also be expected to undertake guided independent study. Information about module study hours including contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

Accreditation details

The Department for Education awards the QTS part of the qualification following recommendation from the university. The PgCE(with QTS/non-QTS) is awarded by the University of Reading.

Assessment

Assessment of University based assessment tasks will involve meeting the stated criteria for each task. Assessment of school-based work will include observation and feedback on practical teaching and assessment against the curriculum expectations and the Teachers' Standards. Further information is contained in the individual module descriptions.

Progression

Students are required to pass all three placement modules to pass the programme.

- Students failing the Autumn placement module (ED3SIP) will normally be required to suspend the programme until the following Autumn
- Students failing the spring placement module (ED3GIP) will not progress to the summer placement module; instead they will be offered a resit during the next placement opportunity and normally undertake their summer placement module during the Autumn term in the next academic year.
- Students failing the summer placement module (ED3IIP) will be offered a resit during the next placement opportunity, normally during the Autumn term in the next academic year.

Classification

Level 6 modules

To pass each of the level 6 placement modules, students must meet the curriculum check-point requirements as stipulated per module. These check-point criteria meet DfE requirements and cumulatively lead to recommendation of Qualified Teacher Status.

Professional Graduate Certificate in Education (PgCE) with QTS:

- i. students must pass all level 6 modules.

Additional costs of the programme

Travel, accommodation and subsistence: students cover the cost of transport to and from the placement school for each placement.

Costs are indicative and may vary according to optional modules chosen and are subject to inflation and other price fluctuations. Estimates were calculated in 2026.
