Programme information and content

Our degree in Modern Languages and English Literature allows you to develop knowledge of a variety of literary, cultural and historical texts from different places and written in different historical periods, together with a high level of proficiency in your core modern language. You will have the opportunity to consider different methods of critical analysis and you will develop your skills in close reading and interpretation. More generally, the course aims to foster an independent approach to formulating problems and arguments, using the close reading and analytical skills that are fundamental to both disciplines, and sensitivity to cultural difference. Our teaching places an emphasis on interactive, student-centred learning and you will be supported as you develop your own writing skills.

You can start the study of your core language at beginner, intermediate or advanced level (post-A level or equivalent). This programme will allow you to achieve level C1 (or above) of the Common European Framework of Reference (CEFR). Your degree transcript will specify which language you have studied and which level you have achieved.

Studying a modern language and English literature opens a variety of career paths. These include careers in publishing, international organisations and charities, teaching and translation, marketing, the public sector and the media. The degree will equip you with a range of transferable skills, including understanding and evaluating evidence, research skills, structuring ideas and communicating them effectively, and intercultural competence.

Part 1:	In Part 1 we consider the major literary genres (poetry, prose fiction as well as drama); study key issues and developments in language, history and culture relevant to your core language; and introduce key disciplinary debates. You will also develop your practical language skills in your core language in all four areas (speaking, writing, reading, listening) and apply key terms in the structural analysis of language.
Part 2:	Provides you with greater breadth and depth of understanding by studying texts and other cultural works (in English and your core language) from

	different historical periods and from different perspectives. It further develops your practical language skills in your core language module, building on the work done in Part 1.
Placement/Study abroad year:	The Year Abroad will give you the opportunity to apply and enhance your practical language skills in either a work or study environment, or a combination of both. You will further develop your adaptability and self-reliance as well as your sensitivity to cultural difference.
Part 3:	Our final year allows you to specialise further; these modules also enable you to contribute to debates that shape our subjects by choosing from a range of modules built around the research specialisms of our staff. Part 3 develops your existing skills in your core language, refining your use of more complicated structures as well as variation in register and style.

10	Find, select and evaluate information from a variety of scholarly sources
11	Define complex problems and identify appropriate strategies to solve them
12	Demonstrate intercultural awareness, understanding and competence

In English Literature

You must take 20 credits of optional modules available in the Department of English Literature.

In Modern Languages

Students must take one 20-credit module in the chosen language. The module taken will be dependent upon the language level at entry.

Students must take at least one 20-credit culture module in the chosen language.

Your remaining 20 credits will be made up of optional modules available in the Department of Languages and Cultures.

The module ML2PYA Preparing for the Year Abroad Part 2 is compulsory for all students on the 4 year programme with a Year Abroad.

In English Literature

Students must take 60 credits of modules from the Department of English Literature. This must include at least with one module from a list of up to 4 modules covering historical periods before 1900, as specified by the department.

In Modern Languages

Students must take one 20-credit module in the chosen language which will be dependent on the level studied at Part 1.

Students must select at least 20 credits of optional culture modules in the chosen language.

Your remaining 20 credits will be made up of optional modules available in the Department of Languages and Cultures.

If you take a year-long placement or study abroad, Part 3 as described below may be subject to variation.

Part 3 Modules:

In English Literature

Students must select 60 credits from the Department of English Literature.

In Modern Languages

Students must take one 20-credit module in the chosen language to reach C1 level (or above) in the Common European Framework of Reference (CEFR).

Students must take at least one 20-credit culture module in the chosen language.

Your remaining 20 credits will be made up of optional modules available in the Department of Languages and Cultures.

Placement opportunities

You may be provided with the opportunity to undertake a credit-bearing placement as part of your Programme. This will form all or part of an optional module. You will be required to find and secure a placement opportunity, with the support of the University

Optional modules:

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your programme can be found online in the Course Catalogue. Details of optional modules for each part, including any additional costs associated with the optional modules, will be made available to you prior to the beginning of the Part in which they are to be taken and you will be given an opportunity to express interest in the optional modules that you would like to take. Entry to optional modules will be at the discretion of the University and subject to availability and may be subject to pre-requisites, such as

completion of another module. Although the University tries to ensure you are able to take the optional modules in which you have expressed interest this cannot be guaranteed.

Teaching and learning delivery:

Your learning experience will involve a mix of language classes, lectures, asynchronous recorded content and seminar discussion, as well as workshops and tutorials. Some modules may include group work.

Elements of your programme will be delivered via digital technology.

The scheduled teaching and learning activity hours and amount of technology enhanced learning activity for your programme will depend upon your module combination. In addition, you will undertake some self-scheduled teaching and learning activities, designed by and/or involving staff, which give some flexibility for you to choose when to complete them. You will also be expected to undertake guided independent study. Information about module study hours including contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

Assessment

Across your four years of study, you may be assessed by coursework essays, written examinations/tests and oral examinations, but you will also be asked to do assessed presentations, develop learning journals, write Critical/Creative work, and/or undertake research projects. Detailed guidance will be given for assessment methods that are unfamiliar. Further information is contained in the individual module descriptions.

Progression

Part 1

To achieve a threshold performance at Part 1, a student will normally be required to:

- (i) Obtain an overall weighted average of 40% over 120 credits taken in Part 1;
- (ii) Obtain a mark of at least 40% in individual modules amounting to not less than 80 credits taken in Part 1; and
- (iii) Obtain marks of at least 30% in modules amounting to 120 credits. (A Fail in a Pass/Fail module will be treated as not meeting the minimum threshold requirement for progression or classification. Pass/fail modules are excluded from weighted average calculations but must be passed to avoid failure of the Part or degree.)

In order to progress from Part 1 to Part 2, a student must achieve a threshold performance; and

(iv) Obtain a mark of at least 40% in their 20-credit core language module.

The achievement of a threshold performance at Part 1 qualifies a student for a Certificate of Higher Education if they leave the University before completing the subsequent Part.

Students considering transferring to another programme should seek guidance from their designated Support Centre in the first instance.

Part 2

To achieve a threshold performance at Part 2, a student shall normally be required to:

- (i) Obtain a weighted average of 40% over 120 credits taken in Part 2; and
- (ii) Obtain marks of at least 40% in individual modules amounting to at least 80 credits taken in Part 2; and
- (iii) Obtain marks of at least 30% in individual modules amounting to at least 120 credits. (A Fail in a Pass/Fail module will be treated as not meeting the minimum threshold requirement for progression or classification. Pass/fail modules are excluded from weighted average calculations but must be passed to avoid failure of the Part or degree.)

In order to progress from Part 2 to Part 3, a student must achieve a threshold performance; and

- (iv) Obtain a pass in the Year Abroad.

The achievement of a threshold performance at Part 2 qualifies a student for a Diploma of Higher Education if they leave the University before completing the subsequent Part.

Additional costs of the programme

For textbooks and similar resources:

In Modern Languages: we recommend that you budget between £50 to £75 a year. The core textbook(s), which most students normally purchase, cost(s) £25 new, and there may be other books/resources which you would find it convenient to buy.

In English Literature: we recommend that you budget between £150 to £250 a year.

Some books may be available second-hand, which will reduce costs. A range of resources to support your curriculum, including textbooks and electronic resources, are available through the library. Reading lists and module specific costs are listed on the individual module descriptions.

Printing and photocopying facilities are available on campus at a cost of £0.05 per page.

For students studying on a year abroad, a discounted fee of 15% of the normal Tuition Fee is payable to the University for the year abroad, as detailed in the Fees Policy. No Tuition Fee is paid to the host institution abroad for which there is a valid exchange agreement in place.

Year Abroad: You may incur additional costs, in addition to those which you would normally expect to pay at the University, during your year abroad, in accordance with clause 6.4 of the Terms and Conditions for Undergraduate Students. These additional costs will depend on your host institution and destination, but may include the purchase of a visa, and mandatory medical insurance. Students will be briefed on these issues prior to them submitting the form detailing the institutions to which they would like to be allocated, and general information on additional costs is discussed in the Year Abroad preparatory meetings. Further indicative details on costs and funding are available on the UoR Erasmus & Study Abroad webpages and the webpages of the host institution.

Costs are indicative and may vary according to optional modules chosen and are subject to inflation and other price fluctuations. Estimates were calculated in 2026.
